4) CRPD Report • Financial partnership with aquatic teams (Marlins and Cordettes) – our non-profit number is being used by both aquatic teams. Not sure how they connected to us. These are parent organizations that worked with Friends of Cordova (prior to us). Two bank accounts operating under our non-profit number. Patrick investigated when he found out but did not know they were using our tax id number. They were raising money for the pool project, but never really clear how they were connected. Now we have this new foundation, with COVID, they were not active. Unofficial or official connection since we just changed the name. 11K synchro 1,278.00 ear marked for the Blue Marlins now they want a storage shed and want to see how

their funds can be used towards that. No one outside of their organization is checking their books. Either way they need some over sight. 2,100 dollars in synchro, swim team thinks that they gave to the pool towards the Friends account. That is confirmed. Concerns about how they are tied to us and using our number. Should we keep them or ask them to get their own id number? Should we learn about them and then call a special meeting in a few weeks and decide? Time is not really on our side. Their accounts are okay.

Advantages – it's a community benefit, 250 swimmers each year, best programs for our community, and a cohesiveness in our city. Supports two excellent programs, and taking work off of the parent volunteers. Most of the people in the Polar Bear fund were these people. High profile and high attendance.

Cons – two budgets, two boards, can take over their accounts, or we can audit their accounts. We need to check with Matt how we can do that. Either one of those has a degree of work. Quarterly spot check – make sure that the checks and balances happening. Everything looks to be in order at this point. Do they want their separate bank accounts? We would need some benefit to oversee, or are we just going to do this for free? Should we just come to the table with their board members to find out if this partnership is rationale? They should give us monthly updates. What is our liability? Yes, it does open us up to liability? Do they have their own insurance? Patrick is looking into what the insurance carrier will do. Why do they do to be tax exempt? Lots of athletic organizations are not part of a non-profit? Historically they wanted it. Those type of sponsorships needed that status. Now with the new pool, they have a resurgence. RCAA is talking about making themselves a non-profit so that can be another option. Does this support our mission? Let's table this and figure out the short term and long term benefits? Let's bring folks from their organizations too to the next meeting this week.

Took a mentor from Splash to talk with and partner. Worked with Patrick to find out what we should ask for this year. Taking more of a grass roots approach that no donation is too small.
