- 2. Update on mailing (The next Activity Guide may be digital) During this time, print is not a good use of resources. It will go out to all of our customers. Unknown what will happen this summer and in fall. Follow the Sacto County Health guidelines, that is driving the ship. Getting our non-exemption status is still in the works. Since the IRS is shut down, we are not able to get our exemption status (which we should be able to on their website). We are asking to see if CRPD could have a presence in the on-line format.

Still uncertain if we can offer anything at this point. May not be appropriate to raise funds when folks do not have a lot to give at this point nor do we have anything we can identify at this point.
